

# For Immediate Release August 4, 2021

(St. Thomas, ON) Elgin health service providers have entered into a Collaborative Decision Making Agreement (CDMA) — an important step toward achieving official Ontario Health Team (OHT) approval by the Ministry of Health. The Agreement formalizes the collaborations between team members and determines how they will work together to make decisions about the proposed Elgin Ontario Health Team (Elgin OHT).

Entering into a CDMA is a key milestone reflecting the culmination of many months of work by health care partners from across the continuum of care including administrators, board governors, physicians, and patients/caregiver partners. All approved OHTs are required by the Ministry of Health to establish and document a CDMA between members to be eligible for OHT implementation funding.

The Agreement outlines various arrangements for the proposed Elgin OHT, including its Vision, Values, and Guiding Principles. The CDMA also outlines a consensus decision-making model that will guide the team in their planning, priority setting and decisions.

The Elgin OHT submitted its full application to the Ministry of Health earlier this year to become an OHT. Once approved by the Ministry, the team will proceed with further detailed planning and establish working groups / integration tables for targeted populations to better coordinate and integrate health services.
